Around 9.30 am to 10. am we arrived at DTC, wherein the police detained me and nobody or any police official has ever talked to me anything, nor I have given any statement to the police.

3. I submit that I was taken to Govt Hospital, Pargi and after my medical checkup, the police has taken my




