# From COMMISSIONER'S DESK

It is with immense pride that I present this annual report, a vivid testament to the unwavering dedication and tireless endeavours of the Hyderabad City Police in safeguarding the community and ensuring the security of our beloved city.

This year, I am overwhelmed with gratitude for the citizens of Hyderabad. Your steadfast cooperation during numerous festival processions, admirable composure during sensitive incidents and proactive decision to voluntarily refrain from using DJs during religious processions exemplify the very essence of communal harmony and responsible citizenship.

The peaceful conduct of Parliament elections, alongside major events, festivities and religious processions is a testament to meticulous planning, seamless execution and exemplary coordination. Above all, it underscores the invaluable synergy between the resilient spirit of our citizenry and the tireless dedication of every member of the Hyderabad City Police.

Amidst a bustling calendar, our investigation teams have achieved remarkable breakthroughs in detecting several sensational cases. By embracing advanced investigative techniques, leveraging cutting-edge technology and fostering specialized training, we are intensifying our fight against cyber crime, substance abuse and illicit trafficking. Prioritizing child safety, we introduced special POCSO training for teachers, equipping them to better address and prevent crimes against children.

The response time to emergency calls has been improved to an impressive 5-6 minutes, demonstrating our commitment to prompt and effective policing. Special emphasis has been placed on strengthening night policing and maintaining vigil over all forms of criminal activity during night hours.

Furthermore, the induction of 1,127 new police constables into the force augurs well for city's security, traffic management and the overall efficiency of the Hyderabad City Police.

Addressing the pressing concern of traffic management, we have implemented transformative measures such as Operation ROPE - Removal of Obstructive Parking and Encroachments and innovative engineering solutions. Complementing these initiatives, our dedicated Traffic Training Instructors have conducted widespread awareness campaigns, touching the lives of thousands and instilling a culture of road safety. In an innovative and revolutionary step, 44 Transgenders were enrolled on a pilot basis as Traffic Assistants by the Traffic branch.

We are profoundly greatful to our Hon'ble Chief Minister Shri A. Revanth Reddy, whose visionary leadership and continuous support has been a beacon of inspiration, guiding us in our pursuit of transforming Hyderabad into India's safest city and also one of the finest globaly cities. May our collective efforts pave the way for a future where Hyderabad radiates as a symbol of safety and harmony.









An Indian Police Service officer of the 1991 batch, Sri C.V. Anand's illustrious career has seen him navigate the diverse landscapes of policing, both within and beyond the department.

His initial decade was a baptism by fire, spent as ASP and SP in Warangal, Adilabad, and Nizamabad, the Maoist-infested districts of Telangana, where he led from the front, survived several exchanges of fire, inflicted significant blows to the

Maoists and earned the coveted President's Gallantry Medal in 2002. This valorous spirit would continue to define his leadership throughout his service.

He has an experience of around 15 years of Metropolitan Urban Policing in his tenure as DCP East and Central Zones of Hyderabad City for 3 years, Commissioner of Police Vijayawada City for 2 years, Traffic Commissioner Hyderabad City for 3 ½ years and Commissioner of Police Cyberabad for 3 years and Commissioner of Police Hyderabad for around 3 years till date. He was the first DCP of the newly created Central Zone as part of reorganization of Hyderabad City Police. With the establishment of the 'Lake Police' in May 2002, he significantly improved security measures around Hussain Sagar Lake preventing numerous suicide attempts.

A visionary leader, Mr. Anand is credited with ushering in a new era of traffic management in Hyderabad as Addl. Commissioner of Police, Traffic from 2010 to 2013. He spearheaded the implementation of "Drunk Driving Enforcement," revolutionizing traffic enforcement with e-challans, handheld cameras, and speed guns. These initiatives, coupled with his unwavering support for the welfare of traffic police personnel, resulted in a marked improvement in traffic flow and safety. The proposal to give 30% extra pay to traffic policemen was moved by him in 2012 and got approval of government in 2015.

His stewardship during the turbulent period of state bifurcation, as the last Commissioner of the undivided Cyberabad, was exemplary. He implemented a transparent system for handling land disputes, bolstered women's safety measures specially in the IT Corridor like SHE Teams, SHE Shuttles, SHE App, and revitalized the defunct Cyberabad Security Council. His commitment to community policing led to the installation of over two lakh CCTVs, significantly enhancing crime prevention capabilities.

Mr. Anand's acumen extends beyond the realm of law enforcement. His two-year stint as **Director of Excise** and then as **Civil Supplies Commissioner** for 2 years saw the introduction of e-PDS, a technological marvel that yielded a staggering Rs. 2000 Cr in savings for the government by curbing illegal activities of rice millers, ration shop dealers and transporters, earning national recognition for his IT-driven reforms.

His illustrious career extends beyond the borders of Telangana. As IG of the Airport Sector in the Central Industrial Security Force (CISF) for 21/2 years, he introduced systemic and technological advancements, streamlining passenger security checks and improved the turnover ratios in all airports. His leadership during the COVID-19 pandemic was lauded by all stakeholders. Anand, also, temporarily assumed additional responsibilities for the South and West Sectors, gaining valuable experience in overseeing steel plants, oil refineries, defense establishments, ports, and other CISF-protected facilities.

Mr. Anand's dedication to continuous improvement is evident in his tenure as **Director of the National Industrial Security Academy (NISA)**. He elevated the quality of training for Assistant Commandants and Sub-Inspectors, incorporating innovative modules like horse riding, rock climbing, and greyhound handling.

Mr. Anand is a recipient of numerous accolades, including the prestigious Election Commission of India National Award for Best Performance in the 2014 General Elections and the National e-Governance Award 2017, the Telangana Excellence Award-2017, apart from the Gallantry Medal, IPM, PPM, and Antrik Suraksha Medal in Police.

In 2021, he returned as Commissioner of Police, Hyderabad, spearheading the establishment of the Hyderabad Narcotics Enforcement Wing (H-NEW) and introducing the Fitcop app for police personnel's health. Notably, his tenure saw the appointment of the first-ever women Inspectors as Station House Officers. He was instrumental in reorganisation of Hyderabad City Police after 35 years. Several specialized wings, including the SMIT, H-NEW, Women Safety Wing and Cyber Crime Wing were established to address emerging challenges. This strategic restructuring has resulted in a more robust and efficient police force, with the city now divided into 7 Zones, 28 Divisions, 71 Law and Order Police Stations, and 31 Traffic Police Stations with an extra force of 1200 being added.

In December 2023, a new chapter unfolded as Mr. Anand assumed the role of **Director General of the Anti-Corruption Bureau**. His leadership resulted in a record-breaking number of 145 cases booked within a span of eight months, striking fear into the hearts of corrupt officials across the state. He also held additional charge as **DG - Vigilance & Enforcement** for 2 months.

On September 9<sup>th</sup>, 2024, he assumed office as the Police Commissioner of Hyderabad City for the second time, continuing an earlier tenure from December 2021 to October 2023.

A true citizen's champion, Mr. Anand's narrative would be incomplete without acknowledging his fervent passion for sports. He played cricket for Hyderabad state at all levels and toured England with the U 19 team before joining IPS. His athletic prowess extends beyond the cricket pitch. He was the best athlete in National Police Academy and won 100 mts, 200 mts, high-long-triple jumps. He is an accomplished tennis player, having clinched the All-India Police Singles Championship for the CISF. He remains passionately engaged in his pursuits of Cricket, Tennis, and also Golf even to this day.

C.V. Anand is a testament to the power of dedication and innovation in public service. He is a leader who believes in leveraging technology for good governance and citizen-centric services. As he continues his remarkable journey, one can only expect even greater contributions from this guardian of peace and prosperity.

#### RAMZAN FESTIVAL BANDOBUST

- This year, the holy month of Ramzan began on March 13, 2024 and concluded on April 11, 2024. # SHRI RAMA NAVAMI FESTIVAL BANDOBUST

The Historic Bibi-Ka-Alam Processions start from Alawa Bibi (Rein Bazar PS) Kaman Shaik Faiz – Kotla Alijah – Malwala Palace – Charminar – Gulzar House – Panj-e-shah – Kadme Rasool – Mandi Mir Alam – Zehra Nagar – Devdi Nawab Kamal-yar-Jung – Purani Haveli – Alawa Sartooq – Aza Khana Zehra – Kali Khabar and end at Masid-e-illahi, Chaderghat.



#### **GENERAL ELECTIONS HOP (LOK SABHA) - 2024:**

The General Elections to the Lok Sabha and By-Election to the Secunderabad Cantonment Assembly Constituency, held on May 13, 2024, were completed without any incidents, thanks to the comprehensive security arrangements made by the Hyderabad Police for the pre-poll, poll day and post-poll periods. 
- The Clues Team was introduced in 2015 and operates at the division level with 2-3 Crime Scene Officers, a Photographer/Videographer, and a dedicated vehicle. Each team covers 2-3 police stations, ensuring quick response to crime scenes across Hyderabad City.
- The team is highly valued for its efficient collection, handling, and preservation of physical evidence, which helps establish the facts and sequence of events in criminal cases, aiding in crime detection.

- Clues Teams are equipped with advanced tools like the Video Spectral Comparator, 3D scanners for scene reconstruction, and DNA preservation kits. They also provide training to first responders on proper scene cordoning to ensure evidence is preserved correctly.
- The work of the Clues Team plays a crucial role in improving the conviction rate by processing and preserving physical evidence, which is vital for corroborating facts and strengthening criminal cases.

In addition to handling physical evidence, the Clues team also specializes in cyber forensics, utilizing tools for digital evidence collection. They assist in screening drug samples in NDPS cases for Investigation Officers across the Tri Commissionerates, including the "HNEW".



#### FORMATION OF ZONAL CYBER CELLS IN HYDERABAD CITY

The formation of Cyber Cells underscores commitment to staying ahead of emerging cyber threats and ensuring the safety and security of our communities in the digital landscape. Cyber cell was formed zonewise during August 2nd week 2024 with the help of expert trainees from the I4C Delhi Training Workshop to the newly formed zonal cyber cell staff was conducted to the nominated officers and staff from the 7 zones of Hyderabad city.

#### Key objectives of the Cyber Cells include:

- Proactive identification and detection of Cyber Crimes in their respective zones.
- Enhanced collaboration with internal and external stakeholders
- Advanced training and capacity-building for Cyber Warriors
- Effective response to all the cybercrime petitions in the zone for quick redressal for the public.
- The establishment of these Cyber units will significantly bolster our efforts to combat Cyber Crime and protect our citizens from the growing threat of cyber-related offenses.

#### CYBER CRIME INSPECTOR AWARDED 3RD PRIZE BY MHA

Inspector Sri.K. Haribhushana Rao attended the 3rd National Conference of State Cyber Nodal Officers at NCRB, New Delhi, and was awarded the 3rd Prize for the Presentation on Investigation of the AP Mahesh Bank case.



#### **MAJOR DETECTIONS DURING THE YEAR**

#### SPECIAL OPERATION DONE AT GUJARAT

In the month of August 2024, seven teams of Cybercrimes police station Hyderabad participated in a special drive in Gujarat state, apprehending 36 accused individuals, including a Chartered Accountant and seven kingpins accused, while detecting 20 cases of cybercrime, including 11 investment frauds, 4 trading frauds, 4 FEDEX courier frauds, and 1 KYC fraud, with the accused wanted in a total of 983 cases across India, including those from Telangana. Additionally, an amount of Rs. 2,89,63,753/- has been frozen in the bank accounts of the accused. In the detected cases, the total transaction amount is 12,49,53,316/-.

**Cr. No. 887/2023:** Received a complaint from a software employee, stating that, while searching on a Google website, he noticed one online gaming website link named as www.dafabet.com. Then he clicked the link, i.e., https://als.dafabc.org/m/en/live/sport/240-FOOT, and logged into the said website, where he noticed that the fraudsters published fake advertisements to induce innocent people to earn money easily. Unfortunately, he has deposited his hard-earned money in that Dafabet wallet and started playing as directed by them. They lured him to deposit more money by giving some profits initially as such, he added some more money to play the game as directed by them. After that, he tried to withdraw his money; the fraudster didn't allow him to withdraw his funds from the Dafabet wallet and insisted him to deposit more money to withdrew his profits. During this process, he has lost an amount of about Rs. 70,000,000/- during the period from the year 2020 to till 2023. In this regard he requested to take the necessary action and to restore his lost amount. Upon which a case in Crime No. 887/2023 at CCPS, Hyderabad and investigated into. Team led by Inspector Haribhushan and team arrested the accused at Delhi, where he was running a call center with more than 20 employees and seized cash of one crore forty lakhs apart from many mobile phones, SIM cards, laptops, checkbooks, etc.



# AWARENESS PROGRAMMES CONDUCTED BY CYBERCRIME POLICE STATIONS AT HYDERBAD.

Meeting with movie theater owners/managers: Meetings with all movie theater owners and managers were conducted along with digital service providers, and they were instructed to display short films related to cyber crimes in the beginning and during the intermission of a movie and should be mandatorily monitored by managers. So as a result, awareness Short films have been displayed in all the movie theaters and multiplexes across Hyderabad city on various cyber frauds as per the guidelines of the Honorable CM of Telangana to create awareness among people and prevent cyber frauds.

**Exclusive WhatsApp group with all FM radios, print, and electronic media:** This unit is actively engaged in disseminating cyber awareness content through various media channels. On a daily basis, CCPS uploads awareness posters, summaries of cybercrime cases, and write-ups on WhatsApp groups dedicated to cyber awareness. Additionally, audio and video clips are being shared through newspapers, FM radio stations, and TV channels to educate the public and promote awareness about cybercrime. This multifaceted approach aims to reach a wide audience and empower individuals with the knowledge necessary to safeguard themselves against cyber threats."

Cyber crime Hyderabad city through social media platforms: Social media is an effective platform for raising awareness about cybercrime. By sharing informative posts, compelling stories of victims who have successfully overcome their challenges, and insights into how fraudsters operate, precautions ought to be taken if an individual encounters a cyber fraud. We are educating a wide audience. Highlighting the emotional and financial impact on victims is essential for fostering empathy and understanding. Additionally, providing practical advice for individuals who may find themselves victims of cybercrime is crucial for their empowerment. As a result of our cyber awareness initiatives, it has benefitted lakhs of people, creating a significant positive impact.







**Mobile caller tune on the same lines of COVID-19 to create awareness on cyber frauds:** Based on our letter to DOT (CPSirletter), BSNL, as a nodal agency, has been playing a caller tune on the first Wednesday of every month, observed as Cyber Jagrookta Diwas, to raise awareness about cyber crime. Currently, the CCPS is following up on the process with the Department of Telecommunications (DOT) and other telecom nodal agencies to implement the same caller tune across all networks, promoting a unified effort towards cyber awareness.".

The District Child Protection Unit, 4. The Child Line Department, and 5. NGOs (Ashritha, BBA) on 20.06.2024 and 22.06.2024 (two days). Accordingly, 12 children [all boys] were rescued.





# BEGGAR FREE HYDERABAD CITY - SPECIAL RESCUE OPERATION OF STREET/BEGGING CHILDREN

The JB (Juvenile Bureau) Team conducted a child beggar rescue operation with the coordination of other departments. 1. Women and Child Welfare Department 2. Labour Department 3. Revenue Department 4. District Child Protection Unit 5. The Child Line Department and 6. NGOs (Ashritha, BBA). During the period from 19.02.2024 to 24.02.2024. Accordingly, we rescued 155 children from various places in Hyderabad City.





#### FIRST OF IT'S KIND VICTIM WITNESS ASSISTANCE UNIT (VISHWAS)

Hyderabad City Police, in collaboration with Prajwala, a leading anti-trafficking organization, established the first-ever Victim Witness Assistance Unit (VISHWAS) at the Anti-Human Trafficking Unit (AHTU). This initiative aims to improve conviction rates in cases under the Immoral Trafficking Prevention Act (ITP Act) by offering comprehensive support to victims and witnesses.

- Raise awareness about victim rights and legal procedures.
- Facilitate rehabilitation and prevent further victimization through collaboration with Prajwala Home.

VISHWAS represents a collaborative effort between law enforcement and civil society to support trafficking victims, ensuring their rights are protected and their voices are heard in the judicial process.





#### **OPERATION SMILE - X AND OPERATION MUSKAAN PHASE - X**

Under Operation Smile-X, 25 teams in Hyderabad, along with the Juvenile Bureau and AHTU units, collaborated with stakeholders and rescued 632 children. Similarly, Operation Muskaan Phase-X, launched on 01.07.2024, involved the Hyderabad City Police and NGOs, rescuing 524 children and filing 20 criminal cases against employers, with fines amounting to Rs. 37,70,908/-. Hyderabad led Telangana in child labour rescues and penalties, showcasing its commitment to eradicating child labour.

Women Police Stations Zone wise are functioning effectively and are instrumental in addressing domestic violence and helping the helpless women victims. A total of 6884 complaints were received so far at WPS. Counseling sessions were conducted, and 2362 families were reunited through Center for Development and Empowerment of Women (CDEW) Centers. A total of 1468 cases were registered at WPS as of 10th November 2024.

# HYDERABAD NARCOTIC ENFORCEMENT WING

The establishment of H-NEW marks a significant step toward Hyderabad's fight against drugs, aiming to create a safer environment for its citizens through rigorous enforcement and strategic operations. The Hyderabad Narcotic Enforcement Wing (H-NEW) has commenced its operations since 2022. This unit operates under the

supervision of the Deputy Commissioner of Police. H-NEW functions on the lines of the Commissioner's Task lorce, focusing on generating intelligence, conducting raids, detecting and disrupting organized drug trafficking groups. H-NEW aims to disrupts the network of drug suppliers, peddlers, transporters and consumers.

H-NEW co-ordinates with Telangana Anti Narcotics Bureau in the way of sharing crucial information and intelligence with respect to drug peddlers, suppliers, consumers etc., It keeps a special focus on interstate criminals and Foreign Nationals who are involved in drug peddling and trafficking.

#### PLAN OF ACTION OF H-NEW FOR MAKING DRUG FREE CITY

• Identifying everyone in the drug network, from consumers to local peddlers, transporters, main suppliers, agents, and financiers, and bringing them on record.

- Identifying the kingpins of drug suppliers in and around Hyderabad.
- Apprehending foreign nationals and interstate drug peddlers who supply ganja and other narcotic substances illegally into the city and its surrounding areas.
- Monitoring the movements of local drug peddlers and booking more cases to curb the drug menace.
- Focusing on labor addas, railway stations, bus stations, schools, colleges, and IT companies to identify suspects involved in illegal drug activities.
- Coordinating with various agencies like FRRO, DRI, NCB, ED, IB, Excise Department, Jail Department, and Intelligence for cracking down on inter and intra-national drug suppliers.
- Consolidating information from local police on pubs, coffee shops, hookah centers, and other places suspected to be frequented by drug consumers.
- Developing informants to collect advance information on drug peddlers.
- Implementing continuous surveillance and monitoring of individuals previously arrested for drugrelated offenses.
- Maintaining vigilance on transportation, cultivation, and selling points of drugs.
- Using social media platforms for awareness generation and organizing meetings with social media service providers for awareness programs.
- Conducting awareness programs in schools, colleges, educational institutions, and universities by involving students, teachers, and non-teaching staff.
- Training officers in the collection of information and investigation related to illicit drug trafficking.
- Conducting surprise checks in isolated places and dark areas, and keeping a close watch near schools, colleges, universities, and coaching centers.
- Sharing information from SHOs of police stations with District Drug Control Authorities regarding offenses by medical/chemist shops.

- Deporting foreign national drug suppliers and peddlers
- Attaching property under the supervision of TGANB.

# EXERCISING THE POWERS OF THE EXECUTIVE MAGISTRATE

As per the City Police Act, the Commissioner of Police, Hyderabad City is vested with the powers of an Addl. District Magistrate. To initiate preventive action against criminal gangs, rowdies and potential trouble mongers, Commissioner of Police, Hyderabad City exercises powers under Sec. 126 BNSS.

For the year 2024, Commissioner of Police has issued bind over proceedings u/s 126 BNSS against 19 respondents of different rival groups and rowdy gangs for good behavior. Out of 19 respondents, 4 respondents have breached the bonds by committing offences. Action for forfeiture of security bonds is under process.

The Special Branch, Hyderabad City functions under the supervision of Jt. Commissioner of Police, Special Branch, Hyderabad.







To promote inclusivity of the transgender community, Hon'ble Chief Minister of Telangana **Shri A. Revanth Reddy** has initiated the recruitment of transgenders as Traffic Assistants in the Hyderabad Traffic Police Department. Recruitment was taken up in coordination with Women and Child welfare Department and Home Department.

The recruitment was conducted under the supervision of Shri C.V. Anand, Commissioner of Police, Hyderabad with a committee comprising of DCP South West, Home Guard Commandant and Additional DCP CAR, along with officials from the Welfare department.

Out of the 58 candidates who participated in the recruitment process, 44 were selected, comprising 29 transgender women and 15 transgender men. Addressing the newly recruited Traffic Assistants, Police Commissioner C.V. Anand encouraged them to serve as role models for their community and contribute to the reputation of the Hyderabad Police and Telangana State Police department.

On December 6th as part of the Praja Palana - Praja Vijayotsvalu, the 44 transgenders were given their enrolment letters by the Hon'ble Chief Minister of Telangana.

City Police destroy narcotics worth RS. 10.56 Crore. The destroyed drugs included 2,140 kg ganja, 12,669 ml hash oil, 540 alprazolam tablets, 19.34 gram cocaine, four LSD blots, 177.75 gram MDMA, and 70 gram opium.



(01) Interstate drug supplier along with (02) local drug peddlers were apprehended by HNEW in the limits of P.S.Kanchanbagh and seized MDMA drug (80) grams, LSD Blots (10). All W/Rs.13 Lakhs.



(01) Drug Peddler along with (02) associates were apprehended by H-NEW in the limits of Bowenpally PS. Seized Amphetamine Drug total weighing (8.5) KGs, (01) Mahindra XYLO Vehicle Br. No.AP 28 DG 4545 along with (03) mobile phones W/Rs. 8.5 Crores from their possession pertains to Cr.No.515/2024, U/Sec. 8(c),r/w 22(c), 29 NDPS Act 1985.



In the month of October, 2024 Hyderabad City Cyber Crimes unit has successfully conducted a special operation in Rajasthan, resulting in the arrest of 29 accused persons and the detection of 15 major cases by the Cybercrime Police Station. Including 05 Investment fraud, 05 FEDEX Fraud, 03 Customs fraud, 02 Trading fraud with this The arrested individuals are wanted in a total of 243 cases across India, including 28 cases from Telangana. Additionally, an amount of Rs.1,45,94,266/- has been frozen in the bank accounts of the accused. In the cases detected, the total transaction amount is Rs. 8,65,55,854/-



The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Bandlaguda Police have busted an International Smart Phones Smuggling & Snatching Gang and apprehended (17) accused including (05) Sudanese Nationals. SEIZED: - Total property worth 1.75 Cr. 1. (703) Smart Phones. 2. (01) Bajaj Pulser Motor Cycle N.S.200



(01) Nigerian Nation Drug Supplier, (01) Drug Peddler and (01)Drug delivery boy were apprehended by HNEW in the limits of Banjara Hills and seized multiple drugs (i.e., Cocaine wg.36 grams, MDMA wg.140 grams, Ecstasy pills 9 Nos, LSD blots 6, Charas wg.32 grams, MEOW-MEOW wg.41 grams, total weighing (256) Grams, (01) Maruthi Wagnor car, Net cash Rs.2260/-(05) mobile phones total W/Rs.1.10 Crores as well as packaging material from their possession pertains to Cr.No.814/2024U/Sec. 8(c), 21c, 22c, 27A, 27ab, 29 NDPS Act 1985.



A software employee lodged a complaint (Cr. No. 887/2023) at CCPS, Hyderabad, stating he lost Rs. 7 crores to a fraudulent online gaming website, Dafabet. The site lured victims with false profit promises and blocked fund withdrawals. The accused were operating a call center in Delhi with 20 employees. Police arrested them and seized Rs. 1.4 crores in cash, along with evidence like mobile phones, laptops and SIM cards.



Hyderabad Cyber Crime Police arrested one accused person from Bangalore, Karnataka, Bangalore who is involved in Job Fraud. During the investigation it is found the accused was involved in 16 other cases across the country and more cases to be identified during the course of further investigation. The accused person in the name of providing Job in MNC Companies cheated complainant and his seven other friends total to the tune of Rs 46,19,000/-. Cyber Crime Police, Hyderabad registered a case in Cr.No.2570/2023 U/s 66(C)(D) IT Act, 419, 420 IPC and investigated in to.



The offenders were arrested under Cr. No. 269/2024, PS Asif Nagar, for offenses including IPC 395, 342, 113 r/w 34 and Sec 102 Cr.P.C. Seized 328 cell phones valued at Rs. 70,00,000/-.

The accused, tower riggers for Airtel and Jio, were arrested for stealing RRUs, RRHs, and cables across multiple districts. Seized items included 28 RRUs, 600 meters of cables, and 10 cell phones, valued at Rs. 60,00,000.





(02) Ganja Supplier, (04) Associates, (01) Ganja Transporter were apprehended by HNEW in the limits of Asifnagar, Habeebnagar and Kanchnbagh limits and seized total 155 KGs Ganja, (01) White Scorpio vehicle bearing No. OD 10K 0069, (01) Passenger Auto bearing Reg. No.TS15 UE 9359 and Mobile Phones -9 all W/Rs.60,00,000/-.

Cr. No. 253/2024, PS Humayun Nagar, and Cr. No. 93/2024, PS Bhavani Nagar. Seized 164 kgs of ganja, Hyundai Accent car, Santro car, Swift Dezire car, Splendor bike and seven cell phones, valued at Rs. 51 lakhs.







Cr. No. 418/2024, PS Gudimalkapur. The offenders, involved in a robbery using an air pistol to intimidate, were apprehended and seized with Rs. 43.8 lakh in cash, three iPhones, an air pistol, and other valuables totaling Rs. 48.3 lakh.

Seized Rs. 36,35,500/- in fake currency and net cash of Rs. 28,000/- during the operation. And apprehended the accused.





Offenders involved in drug trafficking were apprehended: Syed Abdullah, Anas Ahmed Shaikh and Irfan Raju Shaikh were caught with 144.72 grams of Ogiveed Ganja and cell phones worth Rs. 10,00,000. Hantal Gobardhan was seized with 2 kg of Hash Oil and a cell phone valued at Rs. 20,00,000.

(01) Nigerian drug Peddler and (01) Local drug peddler were apprehended by HNEW in the limits of Film Nagar and Jubilee Hills limits and seized (16) Grams Cocaine, (43) LSD Blots, (01) Hundai I20 Car Br. The accused were operating an unauthorized international telephone exchange in Hyderabad, using equipment like SIM boxes and routers to bypass legal channels. In Cr. No. 70/2024 at Santosh Nagar Police Station, police seized equipment worth Rs. 10,00,000, including 32-slot and 16-slot SIM boxes, Laptops, BSNL SIM cards and more.

NORTH ZONE Cr.No. 226/2024 U/sec. 318(4), 319(2), 336(2), 338, 340(2) r/w. 49, 3(5) BNS of Mahankal PS: The Commissioner's Task Force, North Zone. Hyderabad, busted a fake certificate racket on 14-11-2024 and arrested Yelgam Rajkumar and five others. Rajkumar operated RS Online Service Center, creating fake IDs and certificates, altering Aadhar details and using forged stamps to obtain passports and caste certificates.





TASK FORCE On 26-01-2024, Mohd. Amer, a real estate mediator, and Zubair Ali, a fish fry push cart vendor, were apprehended by Falaknuma PS for drug-related offenses. Seized 26 grams of MDMA under Cr. No. 11/2024, U/s 8(c) R/W 22(c) and 27 of the NDPS Act.

The Hyderabad City Police is functioning with the strength of 12000 plus of all ranks, under the administrative control of the Commissioner of Police, Hyderabad City undertook re-organization up to the level of Police stations including creating various specialized units for the first time in 35 years to cater to the needs of current demography of the city and to address the arising policing challenges associated with. The Administration consists mainly on the following aspects:

- Organized Maintenance of Service particulars in the form of Service Registers manually and online through HRMS Application.
- Transfers and postings annually on long standing basis, administrative grounds/request of individual and also deputations to other Units.
- Disciplinary action under CCA Rules for proper functioning of Hyderabad City Police Unit.
- Awarding Rewards i.e., Commendations, Appreciations, MSEs, GSEs, Cash Rewards, etc. for recognition at individual & Team level and encouragement at the professional front.
- Welfare in the form of sanction of loans for the purpose of education, marriage, health, sports, etc.
- Sanction of all kinds of Leaves i.e., EL, EOL, Medical, HPL, Maternity, Paternity, Child Care, Study, etc.

- Issue of Orders for Promotions to the next rank, preparation of promotion panels.
- Issue of NOCs/Service Certificates for various purposes i.e., study, other employment, etc.
- Ensure prompt disposal of Prajavani petitions received online for effective redressal of grievances.

Provision of necessary logistics and staff for the arms verification exercise resulted in a comprehensive arms data, including details of authorised arms dealers for safe custody served as an encouraging stimulus in the runup towards TSLA-2023 & HoP-2024 elections.

# SOCIAL MEDIA ACTION SQUAD OF HYDERABAD (SMASH)

This is the Action Squad of Hyderabad City Police which was created to be set in motion when a concerted action is required to deal with the handles propagating malicious narratives endangering the law and order. This includes the Law and Order wing, the Task Force and the Cyber Crime Wings too.

As soon as the Social Media Monitoring Unit (SMMU) identifies a post worth taking legal action, the same is informed to the officers on the SMASH group.

Lead is taken from here by the Cyber Crimes Wing of the City Polce which will initiate further course of action – taking down the posts by writing to the concerned platform and/or registering a case and investigating.

Special Branch also gives inputs about the field impact or about the accused.

Once there is a lead, the CP Task Force and L&O wing swings into action in apprehending the accused person at great speed.



The Hyderabad City Armed Reserve (CAR) Police, originally established as the "Afghan City Police" in 1932, was renamed in 1957. It is stationed at Petlaburj Police Lines, Hyderabad. The unit operates directly under the supervision of the Commissioner of Police and is headed by an IPS officer.

Functionally, the CAR Police is organized into four key groups: General, Special Operations, Security, and Logistics. It serves as the armed reserve for the Hyderabad City Police, providing crucial support for law enforcement and security operations across the city. The unit has a sanctioned strength of 5402 personnel, with the actual strength currently at 3808.

- Forces are provided for guards and escorts to all State dignitaries, Union/State protectees, IAS/IPS
  officers, government establisments, courts, hospitals, consulates, UPSC meetings, exam papers, and
  for VIP/VVIP visits.
- Daily platoons (Men & Women) are deployed to various zones for law and order bandobust duties, with
  personnel actively participating in managing riots, dharnas, political meetings, major bandobusts,
  festivals like Ganesh, Bonalu, Ramzan, Sadar, Muharram Matam and rescue operations during natural
  calamities and disasters.
- As per the requirements of Central Prisons Hyderabad & Cherlapally, the force (Men & Women) deployed for Prisoner Escorts for Courts & Hospitals in the twin cities and districts.
- Providing men force for remittance Escorts to other banks in Hyderabad Specialized (9) Teams (QRT-3, CSG-4 & CRAF-2) well trained at the Octopus Training Centre are working (24x7) under the supervision of Jt. CP CAR Hqrs/Addl. CP (L&O) Hyderabad for emergency L&O bandobust duties.

#### 3. CITY RAPID ACTION FORCE (CALL SIGN: FALCON)

- CRAF was started in the year 2018. CRAF is a first-of-its-kind specialized force introduced by the Hyderabad Police which will react quickly in such situations and does not take time for its deployment.
- Apart from handling riots, riot-like situations, communal violence, crowd control, and taking up rescue
  and relief, CRAF will also step in to deal with major law and order issues. Friday bandobust, festivals,
  election duties, and agitations. This force consists of (02) teams with 30 men and women.



# 4. QUICK ACTION TEAM (CALL SIGN: TANGO)

- Formed in 2000, QRT is trained by OCTOPUS for anti-terrorism operations and responds to emergencies in Hyderabad.
- Provides security for the Hon'ble Governor's visits, handles law and order duties, including Friday prayers at Mecca Masjid, and played a key role in the 2006 Mecca Masjid blasts response.



- The City Security Guards (CSG) were formed in 2009 after the Mumbai attacks to tackle terrorism and provide security to the Hon'ble CM, as well as handle major law and order duties in the Twin Cities.
- With 60 personnel trained in counter-terrorism, CSG is stationed at Goshamahal and participates in major law enforcement operations and mock drills with Octopus commandos.

#### **MOUNTED POLICE**

The Role of MOUNTED Police in Hyderabad City.

- The Mounted Police, established in 1950, operates under the supervision of the Dy. Commissioner of Police, CAR Hqrs, and currently has 50 horses, including 5 CYB and 5 RCK.
- They perform law and order duties during festivals like Bonalu, Moharram, Ramzan, Bakrid, Ganesh, and Friday prayers, as well as for cricket match bandobust in the South Zone.
- Mounted Police also conduct lake patrols, saving lives of individuals attempting suicide at Tank, and participate in ceremonial parades for Republic Day, State Formation Day, and Independence Day.

# SAR CPL, AMBERPET

The Special Armed Reserve Central Police Lines (SAR CPL), one of the oldest armed police units in the state, was established on January 27, 1940, by the Nizam Government at Amberpet. Initially known as the Nizam District Police, it was inaugurated by General H.H. Walashan Azam Jah Bahadur, the Prince of Berar. 

The Telangana SAR CPL unit was formally constituted on June 2, 2014, with a personnel strength of 529 (41.68% of the total), including excise platoons. The unit operates under the jurisdiction of the Commissioner of Police, Hyderabad City, as per orders dated August 13, 2012 (D.O. No: 5039).

#### **FUNCTIONS**

- Supervise and coordinate the activities of various wings within the unit and with neighboring districts and other organizations to ensure smooth operations.
- Maintain discipline, high morale and professionalism among the personnel, ensuring they are properly trained, honest and service oriented.
- Ensure the efficient functioning of each wing of the unit, promoting operational effectiveness and accountability.

- Oversee the proper utilization of allocated funds and manage financial matters, including cheque power, in the absence of a regular commandant.
- Foster cordial relationships with both officials and non-officials, ensuring cooperation, trust, and effective communica-tion.
- Safeguard and maintain government property belonging to the unit, while engaging in welfare activities to ensure the well-being of personnel and the surrounding communities.

#### The SAR CPL strength is organized into four main companies and specialized sections:

- 1 HQ Company
- 1 Excise Men Company
- RI- Adjutant Office

- 2 Active Men Companies
- 1 MT Company
- RI- Store RI- Training

#### **ESCORTS**

The following escort duties, originating from Hyderabad, are handled by the SAR CPL:

- i. Prisoner Escorts: Secure transport of ISI terrorists, Naxalites, and other high-risk prisoners.
  - a. Within the state b. PAN India
- ii. Treasury Escort: Safeguarding RBI assets and other nationalized banks.
  - a. Within the state b. PAN India
- iii. Logistical Security: Protection of arms, ammunition, and confidential materials such as examination papers and non-postal stamps.
- iv. Arms And Ammunition Escort: a) PAN India

**GUARDS:** The SAR CPL provides guards for various important locations, including the Old CID Office, Margadarshi Chits and Finance case materials, PTC Amberpet, and unit guards at the Quarter and Main Gate.



- (5572) Home Guard Offices participated in maintaining Law and Order bandobust duties for General Elections in Telangana State, which were held in the month of May' 2024.

- Home Guard Officers who are working at Lake Police Station saved 10 human lives at Tank Band for those who attempted to commit suicide by jumping in the waters.
- Implementation of paperless office correspondence through e-office/HRMS.
- Sanctioned road accident insurance coverage of Rs. 5 lakhs under the Social Security scheme in respect
  of 1) Late A. Sattiah, HG 9342, died on 20-11-2023, and the insurance amount was credited on 03-062024 in the nominee bank account. 2) Late K. Krishnaiah, HG 7285, died on 03-12-2023. The insurance
  amount was credited on 13-03-2024 in the nominee bank account.
- A total of 188 General Home Guards are selected to work in the Traffic Wing as per traffic criteria and approved by the Commissioner of Police, Hyderabad. Out of 188, 109 HGs as per Traffic Seniority list were pass ported to the traffic wing till November 2024.
- This office has motivated the Home Guards officer to apply for TS Police Constable selection. However, a few Home Guard officers have passed the final examination, which was conducted by TSLPRB in the recent past notification.
- Medal for Meritorious Service (01), Utkrisht Seva Padak (34) and Ati-Utkrisht Seva Padal (15) were awarded for the HGs who showed dedication towards duty.

• Sri Suraj Naveen, HG No. 3908, working at Mirchowk Traffic Police Station, has won the Gold Medal in All India Veterans Fencing conducted in the month of June 2024 in Orissa State.



This is a not-for-profit society aimed at promoting safety and security by involving all community stakeholders. The concept primarily adopts a Public-Private

HCSC is a unique initiative to raise awareness about personal safety and security, reduce crime, and enhance overall safety and security in the city, making Hyderabad a safe destination for living and business growth.

#### **GENERAL UPDATES**

- Nearly 10 HCSC awareness sessions were conducted at colleges and organizations to provide an overview of HCSC.
- HCSC set up stalls along with an AV vehicle playing HCSC Forum Videos at the HITEX Property Show, Kompally Property Show, and Nagole Metro Property Show for 18 days from January to November, with close to 5500 attendees visiting and inquiring about HCSC.

#### **CYBER FORUM:**

To make Hyderabad a model city in addressing cyber threats and seizing opportunities in cybersecurity.

#### **Achievements:**

 Cyber Smart: Sessions with 125 schools conducted for 1,33,000 children from primary and middle school government teachers for a training of cyber safety with the help of a portal.

- Cyber Squad: Awareness sessions are conducted in 35 schools with close to 45,000 students on the
  latest cyber-crimes, cyber threats, and precautionary measures to avoid a cyber scam. Students have
  organized activities such as school skits and memes to foster awareness about cyber security in their
  schools.
- Cyber Surakshak Sanstha: Online Cyber Security Sessions with 400 Members of FTCCI were conducted to help organizations on Emerging Cyber Frauds in Businesses," equipping participants to tackle cyber threats.
- Cyber Tech Sentinels: 10 Sessions conducted in Colleges on Cyber Safety & Security with 800 Volunteers

• **Digital Dialogues:** A 1-minute video in English and Telugu was created on 1930 Number to be played at the theaters regularly, along with 10 videos on the latest cybercrimes launched at the summit.

#### **ANTI-NARCOTICS**

- Awareness Sessions: 15 sessions in schools and colleges raised awareness about the dangers of narcotics for more than 15,000 students.
- Poster Launch: A drug abuse awareness campaign was launched with posters and a video to spread the message of a drug-free community.

 NADREP Mega Event: The NADREP Mega Event, organized by the Hyderabad City Security Council (HCSC) and the Hyderabad City Police, aimed to address student substance abuse. 
