Sir,

Under the instructions of our client Sri. T. Harish Rao, S/o. T. Satyanaraya Rao, aged about 50 years, R/o. Villa No.1025, Krinns, Puppalaguda, Ranga Reddy, Telangana, I address you the following legal notice to you.

My client is a Member of Telangana Legislative Assembly from Siddipet Constituency. He is the 7<sup>th</sup> time MLA and he was minister thrice and held important portfolios of finance, health, legislative affairs and irrigation etc. He is very popular leader and enjoys clean and impeccable reputation among the public, his friends, relatives, constituency people and in the society. He is very important leader of the BRS party, which is the main opposition party in the state. Recently the Government started arbitrary action of demolition of houses, commercial establishment etc stating the same to be in the FTL and buffer zones of tanks and lakes in and around Hyderabad. The houses of poor and down trodden people of the society who are living adjacent to the Musi river were marked by the Revenue, Municipal authorities and forced them to vacate them with the threat of demolition. All these actions are taken without following due process of law by taking the law into their own hands.

Several poor people were rendered houseless and some of the persons are rendered jobless and their source of livelihood was destroyed while leaving the structures of the brother of Chief Minster and several of his colleagues and Congress party leaders. The fear psychosis gripped the common man and one of the poor women in Kukatpally area committed suicide in the fear of demolition of her house. School going children were left with no books and shelter due to indiscriminate demolition on Saturdays and Sundays.

My client being public representative and leader of the main opposition party, he along with his colleagues and party leaders visited the places where the poor persons houses are marked for demolition and met large number of victims who came to the BRS party office and assured them to fight for their rights, to provide the necessary legal aid and take up the issue in the assembly and with the Government. You being member of parliament belonging to Congress party and in order defame and damage the reputation of my client on 29.09.2024 you have posted a tweet at around 9.54 PM on X.Com@AnilTpyc in Telugu to the following affect"



The same was denied by my client. But you again tweeted on X.Com stating that "I have seen YOUR tweet. You have only alleged that my allegations are Gobel allegations but you have not given explanation on the allegations. Any how, you have not stated whether you have share in the same or not. You are hiding the truth. No smoke comes without fire.

The baseless and reckless allegation of having some share in the convention centre known as "Ananda Convention" which is alleged to be in the FRL/Buffer zone of lake were made. The allegations are made stating that my client has taken up the cause of common man and indiscriminate demolitions to protect Ananda Convention Centre in which share to my client is alleged. In the tweet you have posted my clients photo with the Ananda Convention Centre to defame and damage my client's reputation. In spite of the denial by my client, you made same allegations again in order divert the people attention and damage my clients clean image and to give a different colour to the fight of my client on behalf of the common man, as if he has vested right in the same. The allegations are made fully knowing that there is no truth in the allegations. The allegations are deliberate, motivated, intentional and wilful with malafide intention. Not even a single iota of evidence is placed on the record to support any such allegations.

After seeing your defamatory tweet several of my client colleagues, relatives, constituency people, friends and others enquired about the same.

The allegations made by you against my clients alleged share in the Ananda Convention are imaginary, made with deliberate intention to defame and tarnish the reputation and image of my client in the society, among his friends, relatives, constituency people and others.

In view of the above, I hereby call upon you to provide documentary evidence in support of your allegations within 24 hours from the date of receipt of this legal notice, you are also directed to withdraw the allegations, remove the tweet and tender an unconditional apology in public to my client. Being an MP belonging to the ruling party in the state you have access to all the records.

Being an MP you are expected to behave yourself with dignity and decorum and not to stooping to so low to make baseless and derogatory allegations against my client.

In the event of your failure to comply with this notice, necessary criminal and civil proceedings will be initiated against you for your defamatory and damaging allegation at your cost.
