Sub: W.P. No. 7305/2017 titled UoI vs Shri D. Ronald Rose & Ors filed before the Hon'ble High Court for the State of Telangana-reg.

Madam,

I am directed to refer to the subject cited above and to say that in the above matter, the Hon'ble High Court for the State of Telangana vide its judgment dated 03.01.2024, disposed of the W.P. No. 7305/2017, inter alia, directing as follows:

- "19. ...the cases of the respondents/officers deserve to be reconsidered for final allocation strictly in accordance with the above guidelines framed on the basis of the recommendations of Shri Pratyush Sinha committee between the States of Telangana and Andhra Pradesh...
- 20. ... before considering the representations of the respondents/officers, the petitioners shall give an opportunity of personal hearing to the respondents/officers and pass appropriate orders in accordance with law."
- 2. In compliance of the above directions of Hon'ble High Court, this Department vide Order No. 22012/04/2024-AIS.I dated 21.03.2024, constituted a single member Committee comprising Shri Deepak Khandekar, IAS (Retd.), former Secretary, DoPT for reconsideration of final allocation of AIS officers [respondents in WP(C) No. 5896/2017 & connected matters] of erstwhile State/Cadre of Andhra Pradesh between successor States of Andhra Pradesh and Telangana, in accordance with guidelines/recommendations of the Pratyush Sinha Committee.
- 3. Simultaneously, this Department vide letter No. 22012/04/2024-AIS.I dated 21.03.2024 requested the State Governments of Andhra Pradesh and Telangana to seek representations from the concerned Officers in their respective State/Cadre and forward the same to this Department. The State Government of Telangana vide their letter No. 446/SPL.A/A1/2024-1 dated 10.04.2024, forwarded the representation dated 07.04.2024 of Shri D. Ronald Rose.
- 4. The Committee considered the representation of Shri D. Ronald Rose, the submissions made by him before the Committee in a personal hearing on 25.06.2024, and material available on record. After due examination, the Committee finally recommended to reject Shri D. Ronald Rose's claim of allocating the Telangana cadre to him. The recommendation has been accepted by the Competent Authority in this Department.
- 5. Therefore, Shri D. Ronald Rose, IAS (AP:2006) stands relieved from the State Government of Telangana with immediate effect. He is to be directed to join the State
